2008 POLICIES, PROCEDURES, AND RULES

Goals of the Edgerton Henry Street Farmers' Market

- To enhance the image of downtown Edgerton by providing a vibrant, healthy, and broad based community activity in the heart of the downtown
- To draw attention to downtown retail and recreational opportunities
- To foster positive social interaction between a cross-section of farmers, the arts community, not-for-profit community groups, community members, and visitors
- To promote a healthy lifestyle by making available a wide variety of quality, fresh produce and farm products
- To provide an educational forum for consumers to learn the uses and benefits of high quality locally grown produce and other agricultural products
- To offer growers and producers of agricultural commodities a community-supported forum to showcase their products
- To present consumers and local farmers an opportunity to interact directly with one another
- To preserve Wisconsin's unique agricultural heritage and the historical role Farmers' Markets have played in that heritage

List of Approved Products

A. All products must be Wisconsin, grower-grown or a paid/registered vendor may represent another Wisconsin vendor/Wisconsin grown product after written approval from the Market Manager. Exceptions to this rule are made at the discretion of the Market Manager. Farm products welcome at Market include:

- Fruits and vegetables
- Meats, eggs, and cheese
- Bakery items and candy (vendor produced in a licensed commercial kitchen)
- Canned fruits and vegetables (vendor produced in a licensed commercial kitchen)
- Honey, sorghum, syrup, and molasses
- Cider
- Plants: annuals, perennials, nursery stock, house plants, fresh and dried flowers, and fresh and dried herbs
- Items made entirely with raw agricultural products

B. Products outside of the “List of Approved Farm Products” are not allowed to be sold at Market without the expressed permission of the Market Manager.

Vendor Eligibility

A. All individuals and organizations, whose goods are in compliance with Market rules and guidelines and wish to participate at Market, must complete the appropriate paperwork and submit all necessary local, state, and federal regulatory documentation to be a farm vendor.

B. A farm vendor will not be allowed to vend at Market without submitting a completed Farm Vendor Application. Once the Market Manager receives all necessary documentation, he/she will process your application and send a confirmation letter confirming the farm vendor's completed application stall and assignment.

C. If a farm vendor sells a product which falls under local, state, and/or federal regulation, the Market Manager may ask him/her to furnish copies of his/her licensure to sell such products.

D. If a farm vendor's regulatory circumstances change after approval of his/her application, he/she is responsible for submitting updated documentation to the Market Manager.

E. Vendors will be accepted on a first come, first serve basis, with preference given to 2008 vendors for stall assignments in 2009.

Farm Vendor Fees

A. *Seasonal Farm Vendor Stalls. 22 weeks, June 5-October 30: \$100. Seasonal farm vendor stalls includes reserved stall and preference of stall location in the Market area. The Market Manager assigns stall locations.*

B. *Daily Farm Vendor Stalls: \$10/day. No reserved farm vendor stall. Market Manager assigns stall locations on a first-come, first-serve basis.*

Farm Vendor Stall Guidelines and Conduct

A. Assignments. Seasonal and partial-season vendors have pre-assigned sites for the season. Daily vendors are assigned farm vendor stalls on a first-come, first-serve basis by the Market Manager.

B. Parking. Adjacent parking for vendor vehicles is limited. Seasonal and partial-season vendors will receive priority in the assignment of stalls with adjacent parking. Daily vendors may or may not have the ability to park closely to their stalls.

C. Stall Set-Up and Strike. Stall set-up is from 12:30PM to 2:00PM. Stall strike is from 6:00PM to 6:30 PM. At strike, trash removal and stall teardown is the vendor's responsibility.

D. Size. Stall sites are 10 feet wide by 10 feet deep. Vendors, product inventory, and display must stay within the allotted stalls. Vendors should try to refrain from extending their activity beyond their stall boundaries or the vendor will have to pay to reserve two stalls.

E. Display. Vendors are expected to provide their own stall furnishings including tents, tables, and chairs. Vendors provide their own signage.

F. Signage. Within the stall space, vendors may want to display signage with the name of his/her business and its location. Organic products may be advertised provided they are certified as organic. The Market Manager may ask to see a vendor's organic certificate at any time.

G. WIC/Senior vouchers. Approved WIC and/or senior voucher vendors may display signage informing their customers of their approved WIC and/or senior Voucher status.

H. Vendor Representation. Vendors may be represented by a family member or an individual who participates in the production of the products sold. Vendor representatives must be listed on the vendor application.

I. Reassignment of Stalls. Vendors must check in with the Market Manager by 1:45PM. Late arriving vendors should notify the Market Manager as soon as they determine their arrival time.

The Market Manager reserves the right to reassign the stall of vendors who not occupy their stalls by 1:45PM.

J. Sales Time. Market sales hours are from 2:00PM to 6:00PM. Vendors should use their best judgment in the observance of this rule.

K. Attendance-Seasonal/Partial Seasonal Stall Holders. Vendors must notify the Market Manager if they will not be present on any contracted Market day. Stall assignment priority for the next season is determined by this year's level of participation.

L. Attendance-Daily Stall Holders: Vendors must provide at least 48 hours notice to the Market Manager of their intent to participate at Market on a specific date barring any unforeseen circumstances. At the time of notification, vendors will also inform the Market Manager of the products they intend to sell.

M. Sales Practices. Vendors must follow all appropriate practices required by law including the use of scales certified for legal trade, proper handling of potentially hazardous foods, certification for products advertised as organic, etc. Enforcement of these practices is left to the proper local, state, and federal agencies.

N. Behavior. Vendors are expected to conduct themselves in a courteous manner to other vendors, Market personnel and Market patrons. Threatening, abusive or harassing behavior constitutes a violation of the Edgerton Henry Street Farmers' Market rules and constitutes grounds for dismissal from the Market.

O. Smoking. Smoking is not permitted anywhere on the Market site.

P. Noise. Loud or disturbing noises should be kept to a minimum in the Market area. Vendors should not play music at a sound level which disturbs other vendors or Market patrons. The operation of motors or engines is generally not permitted.

Q. Disciplinary Action. **The Market Manager uses his/her reasonable discretion regarding the enforcement of Market rules. Warnings will be issued to comply with rules after a warning has been issued and not complied. The Market Manager has the right to dismiss any vendor from the Market for any violation of rules set forth in this document and/or any violation of any regulatory code or law with approval by the Edgerton Henry Street Farmers' Market Board. Any vendor dismissed from the Market surrenders any stall fees paid.**

The undersigned hereby represents that he/she is the Applicant or an Officer or other Authorized Agent of the Applicant named herein and that he/she is over 18 years of age. The undersigned further acknowledges that he/she has read and is familiar with the Edgerton Henry Street Farmers’ Market Policies, Procedures and Rules, and recognizes and agrees by his/her signature hereto that the issuance of any permit is expressly conditioned upon Applicant’s acceptance and continuing compliance at all times with said Policies, Procedures and Rules.

Applicant on behalf of him/herself and his/her heirs, successors and assigns, hereby releases fully and forever, and discharges the City of Edgerton, the Edgerton Henry Street Farmers’ Market, and each and every of their perspective officials, officers, employees and agents from any and all claims, actions, causes of action, damages, costs and/or expenses of any kind or nature, including Attorneys’ fees, however caused and incurred by the applicant, arising from or in any way connected with the issuance of permission to Applicant to be a vendor at the Edgerton Henry Street Farmers’ Market and the resulting operation of Applicant’s business at said Market.

Applicant hereby agrees to indemnify and hold harmless the City of Edgerton, the Edgerton Henry Street Farmers’ Market, and each and every of their respective officials, officers, employees and agents from and against any and all claims, actions, causes of action, damages, costs and/or other expenses of any kind or nature, including attorney’s fees, arising from or in any way connected with the Applicant’s use of public space, operation of Applicant’s business and the use of the same by Applicant’s agents, members, partners, associates, contractors, servants, employees, invitees, and licensees.

The undersigned declares under penalties of perjury that the factual information furnished by him/her in Applicant’s Application is true, accurate and complete to the best of his/her knowledge.

Applicant shall be responsible for compliance with all laws, rules, regulations and ordinances governing the sale of all goods at the Edgerton Henry Street Farmers’ Market.

The Edgerton Henry Street Farmers’ Market Board of Directors reserves the right to terminate the Market Contract of any or all Vendors at any time without cause and without reimbursement of fees paid.

2008 FARM VENDOR REGULATORY CHECKLIST

The following information is provided as a courtesy to vendors. Any variations from the specific items on this list may have additional licensing/permit requirements.

If you intend to sell uncut, unprocessed whole **PRODUCE**:

- You are **not** subject to regulation.

If you intend to sell **HONEY, SYRUP, SORGHUM, and/or MOLASSES**:

- You are **not** subject to regulation unless you would like to claim a grade of product.

If you intend to sell **MEAT, POULTRY, FISH, EGGS, and/or CHEESE**:

- You need a **State Mobile Vending Permit**. Please contact the **Wisconsin State Department of Health and Family Services: (608) 266-2835**. You may also obtain a **State Mobile Vending Permit** application from the Edgerton Henry Street Farmers' Market Manager at **(608) 758-9359**.

If you intend to sell **BAKERY ITEMS, CANDY, CANNED GOODS, JAMS, JELLIES, SYRUP, SORGHUM, and/or SALSA**:

- You need a **License for an Approved Commercial Kitchen**. Please contact **Roger Eychaner, Rock County Health Department: (608) 757-5441**.

If you intend to sell **CIDER**:

- The cider must be properly **labeled**. If you are pressing your own cider, the label must say "not pasteurized." If someone else is pressing your cider, certain procedures must be followed and the label must say "pasteurized." You may view the state statute governing retail cider sales via the Internet at: <http://www.legis.state.wi.us/statutes/Stat0097.pdf>(.) If requested, a copy may also be mailed to you by the Edgerton Henry Street Farmers' Market Manager at **(608) 758-9359**.

If you intend to sell **ORGANIC PRODUCTS**:

- You *may* need an **Organic Certificate**. Please contact a **USDA Accredited Certifying Agent** or the Edgerton Henry Street Farmers' Market Manager, at **(608) 758-9359**, for a list of certifying agents.

If you intend to offer **FREE SAMPLES** of your edible products:

Please contact *Roger Eychaner, Rock County Health Department*, for safe dispensing requirements for free samples: **(608) 757-5441**.

If you are selling more than \$1,000 worth of **ITEMS REQUIRING SALES TAX**, including all non-edible items:

You need a *Wisconsin Sellers Permit*. Please contact the *Wisconsin Department of Revenue: (608) 266-2776*. Additionally you may apply for the *Wisconsin Sellers Permit* via the Internet at:

The cost is \$20.00 for this two-year permit.

If you are selling **HERBS, PERENNIALS, and/or NURSERY STOCK (trees, shrubs)**:

You need a *Nursery Grower's License* if your sales will exceed \$250.00. If your sales will not exceed \$250.00, you are *not* subject to regulation. For retail sales above \$250.00 to \$5,000.00, the *Nursery Grower's License* costs \$40. The *Nursery Grower's License Application* may be obtained via the Internet at:

If you are selling **ANNUALS/HOUSE PLANTS/CUT FLOWERS**:

You are *not* subject to regulation.
